**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On December 2, 2021, Lili and Thomas McDevitt (Complainants) filed a complaint against Levi Water Supply Corporation (Levi WSC) regarding denial of water service.<sup>1</sup> The Complainants filed the formal complaint pursuant to 16 Texas Administrative Code (TAC) § 22.242.

On March 4, 2022, the administrative law judge (ALJ) filed Order No. 4, requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental statement of position regarding the complaint by March 31, 2022. Therefore, this pleading is timely filed.

**I. REQUEST FOR AN EXTENSION**

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On March 16, 2022, Levi WSC filed its' responses to Staff's first request for information. Staff requires additional time to review these responses from Levi WSC and to formulate its' supplemental statement of position. Accordingly, Staff requests that the deadline for Staff's supplemental statement of position be extended to April 14, 2022.

**II. CONCLUSION**

Staff respectfully requests an order consistent with the foregoing request.
