## LEVI WSC'S LIST OF ISSUES

COMES NOW Levi Water Supply Corporation (Levi WSC) and files this List of Issues in response to the Order Requesting Lists of Issues by the Public Utility Commission of Texas (Commission) on May 3, 2022 (Order). Levi WSC respectfully shows the following:

#### I. BACKGROUND

On December 2, 2021, Lili and Thomas McDevitt (Complainants) filed a complaint against Levi WSC regarding denial of water service (Complaint). On April 14, 2022, Commission Staff filed its Supplemental Statement of Position stating that the facts of this case are in dispute and recommended the Complaint be referred to the State Office of Administrative Hearings for a hearing on the merits. The Commission issued an Order requiring Complainants and Levi WSC to file a list of issues to be addressed in this docket by May 12, 2022. Therefore, this pleading is timely filed. Levi WSC does not intend this list to be exhaustive and would reserve the right to address additional issues raised by other parties not contemplated herein.

#### II. PROPOSED LIST OF ISSUES

Levi WSC proposes the following list of issues for consideration if this docket proceeds to a hearing on the merits:

- 1. Are the Complainants "qualified service applicants" within the meaning of 16 TAC § 24.161(a)?
- 2. Is Levi serving the Complainants "as soon as is practical after receiving a completed application" within the meaning of 16 TAC § 24.161(a)?
- 3. Does Levi WSC have good cause for not providing service within 180 days of the date a completed application was accepted pursuant to 16 TAC § 24.161(b)?

### III. ISSUES NOT TO BE ADDRESSED

At this time, Levi WSC has not identified any issues not to be addressed.

# IV. CONCLUSION

Levi WSC respectfully requests the Commission issue a preliminary order including the above issues to be addressed and excluding the issues not to be addressed.
