**LEVI'S MOTION FOR EXTENSION**

**COMES NOW** Levi Water Supply Corporation (Levi) and respectfully files this Request for Extension. On December 2, 2021, Lili and Thomas McDevitt (Complainants) filed a formal complaint (Complaint) against Levi regarding denial of water service.<sup>1</sup> On December 3, 2021, the administrative law judge (ALJ) issued Order No. 1, requiring a response from Levi by December 23, 2021, and requiring the Public Utility Commission (Commission) Staff (Staff) to file a statement of position regarding the complaint by December 31, 2021. Staff filed a Request for Extension on December 22, 2021, requesting an extension to file a statement of position until January 14, 2022. Therefore, this pleading is timely filed. Levi respectfully shows the following:

**I. REQUEST FOR EXTENSION**

Levi, nor its counsel, have received any notice of the Complaint prior to today, December 22, 2021, and were unaware any complaints had been filed. Staff's legal assistant emailed a notification of filing in this Docket 52912 to Levi with its Request for Extension today. Levi respectfully requests time to review the Complaint and respond, accordingly. The Commission is closed on December 24, 27, 28, and 31, 2021. Staff has requested an extension for its statement of position to January 14, 2022. Wherefore, Levi respectfully requests the deadline for its response be extended to January 7, 2022.

**III. CONCLUSION**

Wherefore, Levi respectfully moves that the Commission issue an order granting Levi's request and extend the deadline for Levi to respond to the Complaint to January 7, 2022.


