ORDER NO. 6 REJECTING FIRST AMENDED PETITION AND REQUEST TO RESTYLE DOCKET

In this case, Charles D. Carter seeks streamlined expedited release from Marilee Special Utility District's certificate of convenience and necessity (CCN). The petition was filed on December 3, 2021, and concerns a roughly 146-acre tract apparently owned by Carter Family Farms, LLC. Exactly two weeks after filing the petition, on December 17, 2021, Carter Family Farms sold the tract in question to Sater LP. Thus, since December 17, 2021, the petitioner has lacked any legal right to pursue release of the tract. And yet, during the ensuing three-and-a-half months, the parties have engaged in discovery, 11 pleadings have been filed by the parties, and no less than five orders have been filed by the administrative law judge (ALJ). In other words, everyone's time has been wasted on processing a petition which the petitioner lacked the legal right to pursue.

On March 22, 2022, a "First Amended Petition" was ostensibly filed by Sater. Sater explains that it now owns the 146-acre tract, that it also owns a roughly 130-acre tract, ¹ and that it would like to obtain release for the combined 276 acres. Sater asks that the style of this case be changed to reflect that Sater, not Mr. Carter, is the petitioner.

The request to restyle the petition is denied and the attempt to substitute Sater as the petitioner is denied. The proper course of action would be for Mr. Carter to move to withdraw his

petition in this docket so that it can be closed. If Sater wishes to pursue streamlined expedited release it must file a new petition in a new docket.

By April 12, 2022, Mr. Carter must file a motion to withdraw. If he fails to do so, Commission Staff may file a motion to dismiss by April 18, 2022.

It is not necessary to grant Commission Staff's request for an extension filed on April 4, 2022, because there is no longer a need to determine whether the petition in this case is administratively complete.
