**JOINT STATUS REPORT**

On December 8, 2021, the Executive Director of the Public Utility Commission of Texas (Commission) filed a formal Notice of Violation (NOV) against BT Cooke Solar LLC (BT Cooke) for violations of 16 Texas Administrative Code (TAC) § 25.55(c)(2), concerning BT Cooke's failure to comply with winter weather emergency preparedness reporting requirements. On January 25, 2022, BT Cooke filed a request for hearing, for a settlement conference, and for abatement of the proceeding pending settlement negotiations. On February 7, 2022, Order No. 1 in this proceeding was filed, abating the proceeding.

On June 3, 2022, Order No. 2 in this proceeding was filed, requiring the parties to file a joint status report by July 1, 2022 and by the first day of every month thereafter. Therefore, this pleading is timely filed.

**I. JOINT STATUS REPORT**

Commission Staff and BT Cooke have reached a settlement in principle and are in the process of exchanging redlines to a draft settlement package. To allow time for the parties to finalize a settlement package for the Commission's consideration, Commission Staff, on behalf of itself and BT Cooke, respectfully requests that the abatement of this proceeding be continued with joint status reports due on the first day of every month moving forward.

**II. CONCLUSION**

The parties respectfully request that the abatement of this proceeding be continued with joint status reports due on the first day of every month moving forward.
