AFFIDAVIT


BEFORE ME, the undersigned authority appeared, being first duly sworn, deposed and stated:

1. My name is Donald J. Miller. I am over the age of twenty-one and am competent to make the following statements.
2. I am the General Counsel for Adapture Renewables, Inc. (“ARI”), having its principal place of business at 1901 Harrison Street, Suite 1630, Oakland, California 94612. ARI manages and is responsible for BT Cooke Solar, LLC’s (“BT Cooke”) operations.
3. The facts stated in this affidavit are within my personal knowledge and are true and correct. I verify and affirm that I have personal knowledge of the facts stated within, that I am competent to testify, and that I have authority to make this Affidavit on behalf of BT Cooke.
4. Ordering Paragraph No. 3 in the Public Utility Commission of Texas (“Commission”) Final Order in Docket No. 52924 (“Final Order”) requires BT Cooke to remit payment of the full amount of the \$150,000 administrative penalty on or before 30 calendar days after the date the Commission signs the Final Order.

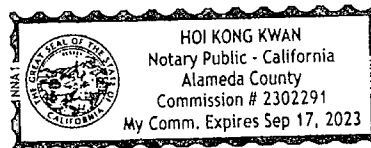
