JOINT STATUS REPORT AND REQUEST FOR CONTINUED ABATEMENT

On December 8, 2021, the Executive Director of the Public Utility Commission of Texas (Commission) filed a formal Notice of Violation (NOV) against Bull Creek Wind LLC (Bull Creek) in the above-styled proceeding. On December 23, 2021, Bull Creek filed a request for hearing. On January 7, 2022, Bull Creek filed an agreed request to abate the proceeding pending settlement negotiations with Commission Staff. On January 13, 2022, the administrative law judge (ALJ) filed Order No. 1, abating the proceeding.

On February 16, 2022, the ALJ filed Order No. 2, continuing the abatement of the proceeding and requiring the parties to file a joint status report by March 11, 2022. Therefore, this pleading is timely filed.

I. STATUS REPORT AND REQUEST FOR CONTINUED ABATEMENT

Commission Staff and Bull Creek continue to engage in settlement negotiations. To allow the parties time to continue discussing the possibility of settlement, Commission Staff, on behalf of itself and Bull Creek, respectfully requests that the abatement of this proceeding be continued. The parties respectfully request that a deadline of April 11, 2022 be established for the parties to file a joint status report regarding settlement discussions and whether continued abatement of this docket is appropriate
