NOTICE OF VIOLATION BY MIDWAY SOLAR, LLC FOR VIOLATIONS OF 16 TAC § 25.55, CONCERNING WINTER WEATHER READINESS REPORTING REQUIREMENTS PUBLIC UTILITY COMMISSION OF TEXAS

JOINT STATUS REPORT AND REQUEST FOR CONTINUED ABATEMENT

On December 8, 2021, the Executive Director of the Public Utility Commission of Texas (Commission) filed a formal Notice of Violation (NOV) against Midway Solar, LLC (Midway Solar) in the above-styled proceeding. On December 22, 2021, Midway Solar filed a request for hearing. On January 18, 2022, Midway Solar filed a joint request to abate the proceeding pending settlement negotiations with Commission Staff. On January 21, 2022, the administrative law judge filed Order No. 1, abating the proceeding. Order No. 1 required Midway Solar and Commission Staff to file a joint status report by March 25, 2022. Midway Solar and Commission Staff filed a joint status report as required. Order No. 2—dated March 28, 2022—requested a subsequent status report by May 2, 2022, "and at the first of each month thereafter." Therefore, this pleading is timely filed for the June 1 deadline.

I. STATUS REPORT AND REQUEST FOR CONTINUED ABATEMENT

Commission Staff and Midway Solar continue to engage in negotiations in good faith. To allow the parties time to continue discussing the possibility of settlement, Commission Staff, on behalf of itself and Midway Solar, respectfully requests that the abatement of this proceeding be continued.

II. CONCLUSION

The parties respectfully request that the abatement of this proceeding be continued.
