JOINT STATUS REPORT AND REQUEST FOR CONTINUED ABATEMENT

On December 8, 2021, the Executive Director of the Public Utility Commission of Texas (Commission) filed a formal Notice of Violation (NOV) against Midway Solar, LLC (Midway Solar) in the above-styled proceeding. On December 22, 2021, Midway Solar filed a request for hearing. On January 18, 2022, Midway Solar filed a joint request to abate the proceeding pending settlement negotiations with Commission Staff. On January 21, 2022, the administrative law judge (ALJ) filed Order No. 1, abating the proceeding. The ALJ’s Order required Midway Solar and Commission Staff to file a joint status report by March 25, 2022. Therefore, this pleading is timely filed.

I. STATUS REPORT AND REQUEST FOR CONTINUED ABATEMENT

Commission Staff and Midway Solar continue to engage in negotiations in good faith. To allow the parties time to continue discussing the possibility of settlement, Commission Staff, on behalf of itself and Midway Solar, respectfully requests that the abatement of this proceeding be continued. The parties respectfully request that a deadline of April 29, 2022 be established for the parties to file a joint status report regarding settlement discussions and whether continued abatement of this docket is appropriate.
