**FIFTH AMENDED RULE 11 AGREEMENT**


Pursuant to Rule 11 of the Texas Rules of Civil Procedure, OCI Alamo 1 LLC (OCI) and the Staff of the Public Utility Commission of Texas (Commission) (collectively, Parties) agree to the following modification of the Fourth Amended Rule 11 Agreement previously signed and filed in this docket and agree to be bound by the following during the pendency of this case to the same extent as if these terms were ordered by the Administrative Law Judge.

**The Parties agree as follows:**

1. OCI and Staff have previously agreed in their Fourth Amended Rule 11 Agreement filed in this docket on August 2, 2022, to extend the deadlines for OCI to file its Motion to Compel Responses to OCI's First Set of RFIs until August 30, 2022, and for Staff to file its Response to OCI's Objections to Staff's Direct Testimony until September 6, 2022.
2. The purpose of the agreed extensions was to allow the Parties to negotiate in good faith to address a possible settlement in this case.
3. The Parties have made progress in their negotiations and have agreed that further deadline extensions will be productive. Therefore, the deadlines mentioned above as previously extended shall each be extended for four additional weeks, until September 27, 2022 (for OCI's filing) and October 4, 2022, (for Staff's filing), respectively.
4. This Fifth Amended Rule 11 Agreement will be filed and made a part of the record in this case.
