#### **ORDER NO. 4**

### FINDING APPLICATION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE, WAIVING NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the administrative completeness of the December 10, 2021 petition of Aqua Texas, Inc. to decertify a portion of its certificate of convenience and necessity number 13201 in Denton and Wise counties. On December 22 and 27, 2021, and February 18, 2022, Aqua Texas filed supplements to the application. On February 18, 2022, Commission Staff filed recommendations on administrative completeness, notice, and proposed a procedural schedule.

The administrative law judge (ALJ) finds the application, as supplemented, administratively complete. Further, the ALJ finds good cause to waive the notice requirements of the Texas Water Code § 13.301(a)(2). In its February 18, 2022 supplement to the application, Aqua Texas filed affidavits signed by the landowners of the two tracts of land, attesting that there are no Aqua Texas customers and waived any right to notice.

The ALJ adopts the following procedural schedule:

If no hearing is requested, deadline for the parties to file joint proposed findings of fact and conclusions of law	May 20, 2022
