**COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON SUFFICIENCY
OF NOTICE**

I. BACKGROUND

On December 15, 2021, Quadvest, LP (Quadvest) filed an application to amend its certificates of convenience and necessity (CCN) in Harris and Montgomery Counties. Quadvest holds water CCN No. 11612 and sewer CCN No. 20952. Quadvest seeks to add approximately 185 acres of uncertificated area.

On May 11, 2022, the administrative law judge (ALJ) filed Order No. 6, establishing a deadline of June 23, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the sufficiency of notice and propose a procedural schedule. Therefore, this pleading is timely filed.

II. SUFFICIENCY OF NOTICE

Staff has reviewed the proof of notice filed by Quadvest and recommends that it be found insufficient. Order No. 2 ordered Quadvest to provide notice of the application as described in the January 18, 2022 memorandum of Patricia Garcia attached to Staff's recommendation. In Ms. Garcia's recommendation, Quadvest is directed to file in the docket, among other things, the publisher's affidavit and tear sheets for proof of newspaper publication. While Quadvest filed the publisher's affidavit, Quadvest did not file the tear sheets for proof of newspaper publication. Instead, they filed what the publisher uses to publish the notice. Therefore, Staff recommends that Quadvest be ordered to file the tear sheets to show proof of newspaper publication.

III. PROCEDURAL SCHEDULE

Staff recommends that notice be found insufficient. Therefore, Staff proposes that the procedural schedule below be adopted:

Event	Date
Deadline for Quadvest to file tear sheets showing proof of newspaper publication	July 7, 2022
Deadline for Staff to file a supplemental recommendation on sufficiency of notice and propose a supplemental procedural schedule	July 14, 2022
Deadline to intervene	30 days after notice is issued

IV. CONCLUSION

For the reasons detailed above, Staff respectfully recommends that notice be found insufficient, that Quadvest be ordered to file the tear sheets, and that the proposed procedural schedule be adopted.
