## **COMMISSION STAFF'S FIRST REQUEST FOR EXTENSION**

On December 15, 2021, Quadvest, LP (Quadvest) filed an application to amend its certificates of convenience and necessity (CCN) in Harris and Montgomery Counties. Quadvest holds water CCN No. 11612 and sewer CCN No. 20952. Quadvest seeks to add approximately 185 acres of uncertificated area.

On July 15, 2022, the administrative law judge filed Order No. 8 requiring Quadvest and the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, Parties) to file joint proposed findings of fact and conclusions of law by September 27, 2022. On September 27, 2022, Staff filed a Request for Extension asking the deadline for the Parties to jointly file findings of fact and conclusions of law be extended to October 5, 2022.

### I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. The Parties need additional time to confer and to prepare the joint proposed findings of fact and conclusions of law. As such, Staff respectfully requests an extension of its deadline until October 21, 2022.

#### II. CONCLUSION

For the reasons detailed above, Staff respectfully requests the entry of an order extending Staff's deadline to October 21, 2022 to file joint proposed findings of fact and conclusions of law.
