DEFINITIONS

- Staff 1-1 The application indicates that the requested area will be served by the Bauer Landing public water system, Bauer Ranch Subdivision, and wastewater system, Bauer Road WWTP. Please provide the comprehensive compliance investigation reports from the TCEQ for these two systems.
- Staff 1-2 The Bauer Ranch Subdivision water system has violations listed in TCEQ's Central Registry database. Provide a statement regarding how the active violations at the Bauer Ranch Subdivision water system will be resolved by Quadvest, L.P. or documentation showing that the violations have been addressed.
- Staff 1-3 If capital improvements are required for the Bauer Landing public water system, and wastewater system, Bauer Road WWTP please provide a capital improvement to for the improvements for each system and proof of the fund sources to pay for the improvements.
- Staff 1-4 Admit or deny if the Bauer Landing public water system, and wastewater system, Bauer Road WWTP have the capacity to provide service to the proposed 99 connections per TCEQ capacity requirements respectively.
