Specifically, the parties have agreed that as compensation for the streamlined expedited release of approximately 113.608 acres of land from Manville WSC's water Certificate of Convenience and Necessity No. 20465 in Williamson County, Texas, 3349 Land Group will reimburse Manville WSC for legal expenses arising from its petition in an amount not to exceed \$3,500.00. No other compensation is owed for this decertification.


