**NOTICE OF APPROVAL  
MAKING A DETERMINATION ON COMPENSATION**

In this Notice of Approval, the Commission determines that, for the streamlined expedited release granted in this docket, 3349 Land Group, LLC owes compensation to Manville Water Supply Corporation under Texas Water Code (TWC) § 13.2541. The Commission previously granted streamlined expedited release and removed 3349 Land Group's tract of land from Manville's certificated service area under certificate of convenience and necessity (CCN) number 11144. The Commission's determination on compensation is based on an agreement between 3349 Land Group and Manville WSC.

**I. Findings of Fact**

The Commission makes the following findings of fact.

**Petitioner**

1. 3349 Land Group is a Texas limited liability company registered with the Texas secretary of state under filing number 800778027.

**CCN Holder**

2. Manville is a Texas non-profit corporation registered with the Texas secretary of state under filing number 26785701.
3. Manville holds CCN number 11144 that obligates it to provide retail water service in its certificated service area in Williamson County.

**Petition**

4. On December 17, 2021, the petitioner filed a petition for streamlined expedited release of a tract of land from the CCN holder's service area under CCN number 11144.
5. In an Order filed on June 16, 2022, the Commission granted the petition and released the petitioner's tract of land from the CCN holder's certificated service area.

6. Ordering paragraph seven of the Commission's Order stated that, if streamlined expedited release was granted, this proceeding would continue for the purpose of determining compensation in accordance with the schedule adopted in Order No. 2.

### **Appraisers and Appraisals**

7. No appraisers are needed to determine compensation in this docket because of the agreement between the petitioner and the CCN holder.

### **Compensation**

8. On June 24, 2022, the petitioner and the CCN holder filed a joint notice of agreement regarding compensation, in which they agreed that \$3,500 is owed to the CCN holder as a result of the streamlined expedited release.

## **II. Conclusions of Law**

The Commission makes the following conclusions of law.

1. The Commission has authority to determine the amount of compensation to be awarded after granting streamlined expedited release under TWC §§ 13.254 and 13.2541.
2. No notice is required to determine the amount of compensation.
3. No opportunity for a hearing to determine compensation for streamlined expedited release is provided under TWC § 13.2541 or 16 Texas Administrative Code (TAC) § 24.245(h)(7).
4. The determination on compensation under TWC § 13.2541 and 16 TAC § 24.245(i) is not a contested case.
5. Under 16 TAC § 24.245(i)(1), if the petitioner and CCN holder agree on the amount of compensation to be paid, they may forego the appraisal process and make a joint filing with the Commission stating the amount of the compensation to be paid.
6. Compensation in the amount of \$3,500 is owed by the petitioner to the CCN holder for the release under TWC § 13.2541.
7. The Commission processed the petition in accordance with the TWC and Commission rules.

## **III. Ordering Paragraphs**

In accordance with these findings of fact and conclusions of law, the Commission issues the following orders.

1. The petitioner must pay to the CCN holder compensation in the amount of \$3,500 within 90 days from the date of this Notice of Approval.<sup>1</sup>
2. The Commission denies all other motions and any other requests for general or specific relief that have not been expressly granted.
