COMMISSION STAFF’S REQUEST FOR EXTENSION

On December 21, 2021, UA Holdings 1994-5 LP dba SC Utilities (UA Holdings) filed an application for a Class D rate adjustment under Texas Water Code (TWC) § 13.1872 and 16 Texas Administrative Code (TAC) § 24.49 for the Meadow Vista Business Park under its sewer Certificate of Convenience and Necessity (CCN) No. 20586. UA Holdings filed supplemental information on January 3, 2022.

On December 22, 2021, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of January 20, 2022, for Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of the application and notice and a recommendation on final disposition if Staff recommends that the application be deemed administratively complete. Therefore, this pleading is timely filed.

I. UNOPPOSED REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time for further analysis of the application so that Staff can complete its recommendation. Staff has conferred with UA Holdings and is authorized to represent that UA Holdings is unopposed to the proposed extension. Staff respectfully requests that the deadline be extended to February 3, 2022.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff’s deadline to February 3, 2022, to file its comments on the sufficiency of the application and notice and a recommendation on final disposition.
