ORDER NO. 3 CONSOLIDATING DOCKETS, RESTYLING THE CASE, FINDING APPLICATIONS ADMINISTRATIVELY COMPLETE, AND ADDRESSING NOTICE

This Order addresses consolidation, administrative completeness, and notice in the above-styled and numbered dockets.

In Order No. 1 filed in all three cases on December 22, 2021, the administrative law judge (ALJ) expressed his intention to consolidate the above dockets. No party objected to consolidation. The ALJ hereby consolidates Docket Nos. 53006, 53007, and 53008 into Docket No. 53006. All future filings shall be made only in Docket No. 53006, which is hereby restyled as follows:

Application of UA Holdings 1994-5 LP dba SC Utilities for a Class D Rate Adjustment

So that the record is complete, the ALJ deems all documents filed prior to the date of this Order on the Commission's interchange in Docket Nos. 53007 and 53008 to be incorporated by

reference and also part of the record for Docket No. 53006. Docket Nos. 53007 and 53008 are

hereby closed.

Commission Staff recommended that the application be deemed administratively complete

and accepted filing and further recommended that UA Holdings provide notice to customers by

March 1, 2022, with an effective of April 1, 2022.

The ALJ finds UA Holdings' application administratively complete and accepted for filing

under Texas Water Code § 13.1872 and 16 Texas Administrative Code (TAC) § 24.49. The ALJ

establishes an effective date for the rate increases of April 1, 2022.

Under 16 TAC § 24.49(e), UA Holdings is required to provide notice to each ratepayer,

using the notices UA Holdings filed on December 21, 2021. The notices must be provided only

after UA Holdings receives a written Notice of Approval issued by the Commission, but at least

30 days before the effective date of the proposed rate change. Because the Notice of Approval has

not yet been issued, the ALJ instructs UA Holdings not to provide notice to ratepayers until the

Notice of Approval is issued in this consolidated docket.
