COMMISSION STAFF'S REQUEST FOR EXTENSION

On January 4, 2022, Quadvest, LP (Quadvest) filed an application under 16 Texas Administrative Code (TAC) § 24.25(b)(2) for approval of a pass-through rate change for fees billed by the North Fort Bend Water Authority (NFBWA) and West Harris County Regional Water Authority (WHCRWA).

On February 8, 2022, the administrative law judge (ALJ) filed Order No. 2 finding the application administratively complete and notice sufficient and requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Quadvest (collectively, the parties) to file joint proposed findings of fact and conclusions of law by February 21, 2022. As the Commission is closed on February 21, 2022, pursuant to 16 § TAC 22.4(a), the deadline is extended to the next day on which the Commission is open for business. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is currently working with Quadvest to ensure the terms of the joint proposed findings of fact and conclusion of law are accurate and correct. Therefore, Staff respectfully requests an extension of time until March 8, 2022, for Staff to file a joint proposed findings of fact and conclusions of law.

II. CONCLUSION

Staff respectfully requests an order consistent with the foregoing request.
