**ONCOR ELECTRIC DELIVERY COMPANY LLC’S
ERRATA TO SUPPLEMENTAL PROJECT NEED DATA**

COMES NOW Oncor Electric Delivery Company LLC (“Oncor”), and files this Errata to Supplemental Project Need Data. Oncor filed an application to amend its certificate of convenience for the Ivy League 138-kV transmission line in Collin County (“Project”) on January 14, 2022. On January 24, 2022, Oncor filed Supplemental Project Need Data (including Exhibits 1-3 thereto) to provide the information requested in the memorandum filed by Commissioner McAdams in Docket No. 50812 on July 14, 2021.

Oncor’s errata corrects the publicly-available “Summary” tab of Exhibit 1 to the Supplemental Need Data, which is an Excel spreadsheet containing historical and forecast loads for the area served by the Project.¹ The originally filed “Summary” tab of Exhibit 1 to the Supplemental Need Data inadvertently omitted the illustration of forecast load in the graph embedded in this Excel spreadsheet, which omissions occurred as a result of redacting the other tabs to this exhibit. A replacement, native public version of Exhibit 1 to the Supplemental Need Data incorporating this sole errata correction is included with this filing.

¹ The other two tabs of Exhibit 1 to the Supplemental Need Data filing—“Calculations” and “Loads Requested”—were redacted in the public version because they are Protected Materials or Highly Sensitive Protected Materials under the terms of the protective order.
