KB HOME LONE STAR INC,'S RESPONSE TO THE JOINT MOTION FOR EXPEDITED PROCEDURAL SCHEDULE

KB HOME Lone Star Inc. ("KB Home"), an intervenor, hereby timely responds to the Joint Motion for Immediate Prehearing Conference and Expedited Procedural Schedule.

KB HOME is actively developing a large residential subdivision in the application's study area. KB HOME therefore generally agrees that having regulatory certainty sooner is beneficial. As a result, KB HOME generally supports the motion to expedite, but proposes to move the start of the hearing to the prior week, i.e., July 12th, thereby allowing two weeks for the reply briefs (without changing the proposed due date for the Proposal for Decision). A few other schedule adjustments would be needed regarding the rebuttal phase of the case to accommodate those changes.

KB HOME has contacted counsel of record in this case to discuss expedited schedule matters, and has received feedback from several regarding the changes identified above, especially Applicant's counsel. Based thereon, attached is a modified expedited schedule. Applicant's Counsel has authorized the undersigned to state that the Applicant is agreeable to the adoption of the attached modified expedited schedule. In addition, two intervenor's counsel and Commission Staff's counsel have indicated agreement with having the hearing a week earlier and two weeks for reply briefs.

KB HOME files this modified expedited schedule at this time, so that all parties can take it into account in any responses they may file regarding the motion to expedite. KB HOME accordingly supports the motion to expedite based on the attached modified expedited schedule.
