AFFIDAVIT ATTESTING TO THE PROVISION OF NOTICE OF HEARING UNDER CHAPTER 26 OF THE TEXAS PARKS AND WILDLIFE CODE

BEFORE ME, the undersigned authority, personally appeared Miguel Alvarado, known to me to be the person whose name is subscribed below who, upon oath, deposed and stated as follows:

- 1. My name is Miguel Alvarado. My business address is 1616 Woodall Rodgers Fwy., Suite 6A-010, Dallas, Texas, 75202. I am over eighteen (18) years of age and have never been convicted of a felony. I have personal knowledge of the facts contained herein, and they are true and correct.
- I am currently employed as Regulatory Manager at Oncor Electric Delivery Company LLC
 ("Oncor"), and I am authorized to make this Affidavit on behalf of Oncor.
- 3. If applicable, Chapter 26 of the Texas Parks and Wildlife Code ("PWC") requires, among other things, the provision of certain notices if a program or project requires the use or taking of any public land designated as a park, recreation area, scientific area, wildlife refuge, or historic site.
- 4. Certain routes filed with Oncor's application for the proposed Ivy League 138-kV transmission line project (the "Project"), if selected by the Public Utility Commission of

- Texas, would cross parks, recreational areas, and/or historic sites. None of the routes filed with Oncor's application for the Project would cross any public land designated as a scientific area or wildlife refuge.
- 5. Pursuant to PWC § 26.002, when a program or project requires notice and a public hearing before approval, the notice of the hearing must be given in writing to the person, organization, department, or agency that has supervision of the land proposed to be used or taken. The notice must state clearly the proposed program or project and the date and place for the public hearing. The notice must be given at least thirty (30) days before the date for the public hearing. Notice must also be given to the public by publishing notice of the public hearing once a week for three consecutive weeks in a newspaper having general circulation in the county where the land proposed to be used or taken is situated.
- 5. On June 3, 2022, State Office of Administrative Hearings Order No. 3 issued and approved Oncor's proposed notices of the public hearing under Chapter 26 of the PWC.
- 6. On June 6, 2022, Oncor provided written notice of the public hearing under Chapter 26 of the PWC by overnight mail delivery to each person, organization, department, or agency that has ownership/supervision of parks, recreation areas, and/or historic sites crossed by routes filed with Oncor's application for the Project. This written notice included, among other things, a clear description of the Project and the date and place for the public hearing under Chapter 26 of the PWC. A representative copy of the transmittal of written notice provided to each owner/supervisor is attached to this Affidavit as Attachment No. 1.
- 7. Attachment No. 2 to this Affidavit lists the owners/supervisors of parks, recreation areas, and/or historic sites who were mailed written notice of the public hearing under Chapter 26 of the PWC.
- 8. One written notice of the public hearing under Chapter 26 of the PWC mailed to an

owner/supervisor of a park, recreation area, and/or historic site at the following address was returned as "Not Deliverable":

This publication of notice provided, among other things, a clear description of the Project and the date and place for the public hearing under Chapter 26 of the PWC. Copies of the newspaper tear sheets are attached to this Affidavit as Attachment No. 4.

TEXAS PARKS AND WILDLIFE CODE CHAPTER 26 NOTICE OF HEARING

Landowner

This provides notice of a concurrent hearing on the merits and hearing under Chapter 26 of the Texas Parks and Wildlife Code ("PWC") in State Office of Administrative Hearings ("SOAH") Docket No. 473-22-2156 and Public Utility Commission of Texas ("PUC") Docket No. 53053 regarding the application of Oncor Electric Delivery Company LLC ("Oncor") to Amend its Certificate of Convenience and Necessity for a Proposed 138 kV Transmission Line in Collin County, Texas. This project involves Oncor's request for PUC approval to construct the singlecircuit Ivy League 138 kV transmission line, on double-circuit capable structures, between the proposed Oncor Ivy League Substation (one mile southeast of the intersection of US 380 and FM 982) and the existing Longneck Substation (located northwest of Monte Carlo Boulevard and FM 75) in the City of Princeton, Texas. The enclosed map illustrates all of the route links Oncor has proposed to build this transmission line and identifies (with corresponding route link and tract crossing descriptions at the top right of the map) the parks/recreation areas and the historic site that this transmission line could potentially cross, depending on the route the PUC selects. You are receiving this notice because you are a person, organization, department, or agency that has ownership/supervision of one or more of the parks/recreation areas and/or the historic site that this transmission line could potentially cross. 


