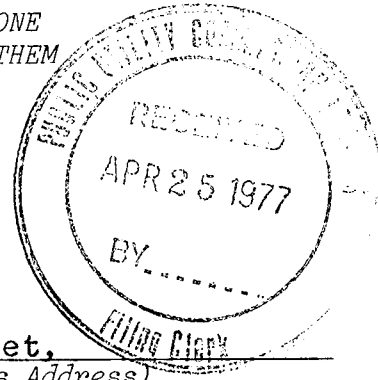

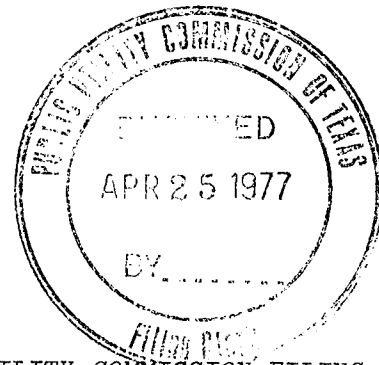

Service Rules and Regulations:

Deposit:

- a. Residential \$15.00
- b. Commercial \$20.00

Reading and Billing:

- a. Begin meter reading on the 20th of each month.
- b. Utility bills mailed on the 1st working day of the month.
- c. Past due notices are sent out on the 15th of each month.
- d. All bills due on or before the 25th of each month.

Cut-off's:

Delinquent accounts.

- a. Cut off day is the 26th of each month or the next working day following the 25th.
- b. Reconnection fee - \$4.00.

Customer requesting service discontinuance.

- a. Deposit is applied to the final bill and if deposit is greater than bill balance is returned to customer by check. If deposit is less than final bill notice for amount due is mailed.

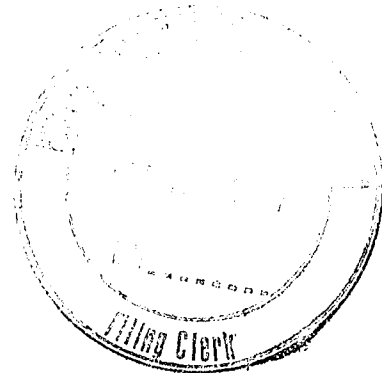
