## SECTION B SERVICE RULES AND REGULATIONS

The Cuney Municipal Water Corporation is familiar with the commission's Complete Substantive Rules and , will abide by those rules and regulations in their entirety and, will keep a current copy on file in the office.

The utility will provide, install, own and maintain meters to measure the amount of water consumed by its customer. Upon request a customer may have his/her meter tested without charge in his/her presence, during normal working hours. For an additional requested test within a four year period, a charge of \$15.00 will be assessed. Proper records will be kept on all meter tests.

Statements will be rendered monthly and, shall not be due until 16 days after the issuance of statement. Bill becomes deliquent if unpaid 20 days after post marked date. Service shall be disconnected if unpaid in 31 days from post mark date.

The utility will offer upon request, a deferred payment plan, to any residential customer unable to pay his bill. The provisions of this plan are set forth completely, in P. U. C. Subst. R. 23.45(C)
