JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

On February 16, 2022, the Staff (Commission Staff) of the Public Utility Commission of Texas (Commission) and Monarch Utilities I L.P. (Monarch) filed a settlement agreement and report in this docket. On March 7, 2022, the administrative law judge (ALJ) filed Order No. 2, requiring clarification from the parties regarding a discrepancy in the affidavit of Mr. Dean Van Horne concerning the amount of money refunded to customers as part of the settlement agreement. On March 21, 2022, the parties filed a response to Order No. 2, including an errata to the affidavit of Mr. Van Horne.

On March 24, 2022, Order No. 3 was filed, requiring the parties to file a supplemental motion to admit evidence in this proceeding by March 31, 2022. Therefore, this pleading is timely filed.

I. SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

For the purpose of supporting the Commission's Order in this proceeding, the parties move to admit the following additional items into the record of this proceeding as evidence:

1. The parties' joint response to Order No. 2, including all attachments, filed on March 21, 2022 (Interchange Item No. 7).
