Lindale Rural Water Supply Corporation; Portion of Water Service Area CCN No. 10758; PUC Docket No. 53148

Application of City of Lindale and Lindale Rural Water Supply Corporation for Approval of Service Area Agreement Under Texas Water Code §13.248 and to Amend Certificates of Convenience and Necessity in Smith County

Pursuant to Texas Water Code § 13.257, Lindale Rural Water Supply Corporation ("Lindale Rural WSC"), holder of Certificate of Convenience and Necessity No. 10758, hereby files this Boundary Description for the water utility service area in Lindale Rural WSC's CCN that was dually certificated with the City of Lindale by the Public Utility Commission of Texas in a May 12, 2022, written order in Docket No. 53148. The area of Lindale Rural WSC's CCN modified by the order consists of a service area described as follows:

The water utility service area is located approximately 3.25 miles south of downtown Lindale, Texas, and is generally bounded on the south by Interstate Highway 20; on the west by County Road 433 (Harvey Road); on the north by .25 miles north of Interstate Highway 20; and on the east by .4 miles east of County Road 433 (Harvey Road). The total added area is approximately 69 acres and 0 current customers.

The water utility service area is further depicted on the attached PUC map.

The Boundary Description is being filed on behalf of and at the request and instruction of Lindale Rural WSC, based upon information and belief. Lindale Rural WSC specifically authorizes the filing of this Boundary Description to comply with Texas Water Code §§ 13.257(r) and (s) and its

associated rules and regulations.




