# COMMISSION STAFF'S SECOND REQUEST TO AMEND THE PROCEDURAL SCHEDULE

On January 26, 2022, Liquid Utilities LLC (Liquid Utilities) filed an application to obtain a sewer certificate of convenience and necessity (CCN) in Montgomery County. The application requests a service area that includes 55 acres and 159 proposed connections.

On October 3, 2022, the administrative law judge (ALJ) filed Order No. 6, which directed Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the application by November 21, 2022. Therefore, this pleading is timely filed.

## I. REQUEST TO AMEND THE PROCEDURAL SCHEDULE

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs more time to review recently filed information by the applicant for the final recommendation. Accordingly, Staff respectfully proposes the following amended procedural schedule.
