**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On January 26, 2022, Liquid Utilities LLC (Liquid Utilities) filed an application to obtain a sewer certificate of convenience and necessity (CCN) in Montgomery County. The application requests a service area that includes 55 acres and 159 proposed connections.

On December 9, 2022, the administrative law judge (ALJ) filed Order No. 8, which directed Staff (Staff) of the Public Utility Commission of Texas (Commission) to file joint proposed findings of fact and conclusions of law by February 9, 2022. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to complete the joint proposed findings of fact and conclusions of law. As such, Staff respectfully requests an extension of its deadline until February 24, 2023.
