**ORDER NO. 6
REQUIRING CLARIFICATION**

This Order addresses SJWTX, Inc. dba Canyon Lake Water Service Company's annual true-up report and application to increase its pass-through gallonage charge. The administrative law judge requires clarification on the following issue:

1. In the proposed tariff attached to Commission Staff's recommendation filed on March 2, 2022, the tariff states the pass-through gallonage charge is applicable to all SJWTX systems except Saddle Ridge and Deer Creek Ranch. However, in the memo attached to Commission Staff's recommendation, Commission Staff states the pass-through gallonage charge applies to all subdivisions under certificate of convenience and necessity number 10692 except Deer Creek Ranch, Kendall West Utility, Bandera East Utility, as well as the Clear Water Estates and the Saddle Ridge subdivisions in public water system identification number 2270049.¹


By May 9, 2022, Commission Staff must clarify the water systems and subdivisions that the pass-through gallonage charge does and does not apply to and file a revised tariff, if applicable. If the pass-through gallonage charge does or does not apply to all subdivisions served by a single water system, Commission Staff may identify the water system by Texas Commission on Environmental Quality identification number and name, if applicable.²

¹ The administrative law judge notes that SJWTX has not received final approval from the Commission to acquire Kendall West Utility and Bandera East Utility and, accordingly, SJWTX cannot seek approval of a change to the pass-through gallonage charge for those utilities. *See Applications of Kendall West Utility, LLC, Bandera East Utility, LP, and SJWTX, Inc. for Sale, Transfer, or Merger of Facilities and Certificate Rights in Kendall, Bandera, and Medina Counties*, Docket No. 52281, Order No. 10 Approving Sale and Transfer to Proceed, Ordering Paragraphs 6 and 7 (Dec. 10, 2021).

² For example, it is unclear whether tariff pages 9 through 11 are applicable only to the Deer Creek Ranch subdivision or the Deer Creek Water system as a whole.
