DEFINITIONS

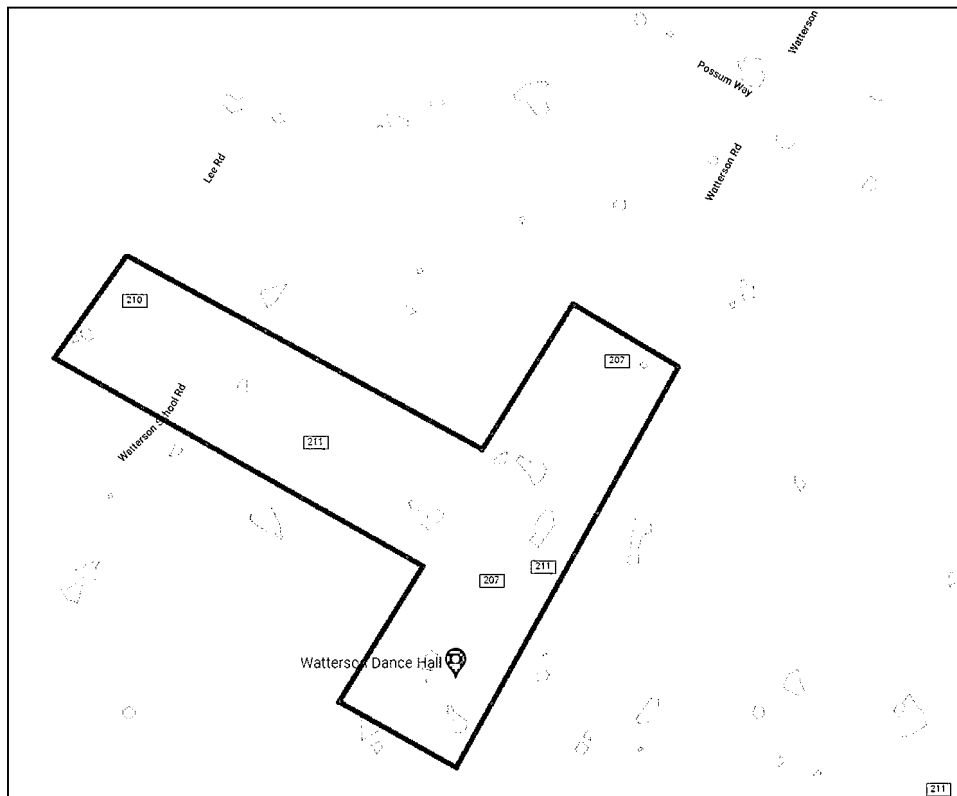

- Staff 2-2 Please provide a detailed list of what fees for water service the Hilbig's have paid for.
- Staff 2-3 Please provide a list of all requirements of the Rules and Regulations Concerning Aqua's Service to Subdivisions that the Hilbig's have and have not complied with.
- Staff 2-4 Please provide a copy of the simulated hydraulic analysis discussed in the "Water Feasibility Study Wilhelm – Hilbig Development" from Steger Bizzell on July 8, 2021.
- Staff 2-5 Please provide a list of all water lines, with line sizes and number of connections per each line, on Lee Road and Watterson Road, for the following area of interest inside the red lines:



- Staff 2-6 Please provide a detailed explanation as to why a new 4" water line is necessary to provide the Hilbig's with water service.
- Staff 2-7 Please provide a copy of the bill of materials and labor costs that support Aqua WSC's proposed tap fee.
- Staff 2-8 Please provide any invoices, receipts, and workorders that support these costs.
- Staff 2-9 Please state if tap installations will be done by the utility's internal employees or by a contractor.
