**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On February 3, 2022, Jacob and Jennie Hilbig (Appellants) filed an appeal of the cost of obtaining service from Aqua Water Supply Corporation (Aqua WSC) under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On March 16, 2022, the administrative law judge (ALJ) filed Order No. 3, setting a deadline of May 11, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide a final recommendation on the petition or to request a hearing. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff submitted a request for information to Aqua WSC on April 20, 2022. Aqua WSC filed their response to Staff's RFIs on May 10, 2022, and Staff requires additional time to review Aqua WSC's responses. Staff has reached out to Aqua WSC and their counsel and they are unopposed to our request for extension. Therefore, Staff respectfully requests the entry of an order extending the deadline for Staff to file a statement of position to June 10, 2022.

**II. CONCLUSION**

For the reasons discussed above, Staff respectfully recommends that the procedural schedule be revised as provided above.
