**AQUA WATER SUPPLY CORPORATION'S REQUEST FOR EXTENSION OF TIME  
TO FILE RESPONSE TO COMMISSION STAFF'S FOURTH  
REQUEST FOR INFORMATION**

COMES NOW, Aqua Water Supply Corporation ("Aqua WSC") and hereby files this Request for Extension of Time to file a Response to the Staff of the Public Utility Commission Texas' ("Commission Staff") Fourth Request for Information ("RFI"). In support thereof, Aqua WSC would show the following:

**I. BACKGROUND**

On February 3, 2022, Jacob and Jennie Hilbig filed an appeal of the cost of obtaining service from Aqua WSC pursuant to Texas Water Code ("TWC") § 13.043(g) and 16 Texas Administrative Code ("TAC") § 24.101(g). On June 23, 2022, Commission Staff filed their Fourth Request for Information to Aqua WSC (Question No. Staff 4-1). Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Aqua WSC requests to extend the deadline to file its response to Commission Staff's Fourth RFI. Aqua WSC requires additional time to address the request outlined in Commission Staff's Fourth RFI. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. Aqua WSC conferred with Commission Staff, and they have indicated that they are not opposed to Aqua WSC's request.

**III. CONCLUSION**

Aqua WSC respectfully requests the issuance of an order granting Aqua WSC’s request and extending the deadline to file a response to Commission Staff’s Fourth Request for Information to July 20, 2022.
