**AQUA WATER SUPPLY CORPORATION'S
LIST OF ISSUES**

Pursuant to the Public Utility Commission's ("Commission's") Order Requesting Lists of Issues filed on July 13, 2022, comes now Aqua Water Supply Corporation ("Aqua WSC") and hereby files this List of Issues, and would respectfully show as follows:

I. BACKGROUND

Aqua WSC is a non-profit water supply corporation operating under the authority of Chapter 67 of the Texas Water Code, and holds water Certificate of Convenience and Necessity ("CCN") No. 10294. On February 3, 2022, Appellants Jacob and Jennie Hilbig filed an appeal of the cost of obtaining service from Aqua WSC under Texas Water Code ("TWC") § 13.043(g) and 16 Texas Administrative Code ("TAC") § 24.101(g). On June 9, 2022, the Honorable Administrative Law Judge ("ALJ") issued Order No. 5, extending the deadline for Staff of the Public Utility Commission ("Commission Staff") to issue a final recommendation on the petition or to request a hearing to July 11, 2022.

On July 11, 2022, Commission Staff filed a Request for Hearing and Referral to the State Office of Administrative Hearings, requesting the issuance of an order referring the case to the State Office of Administrative Hearings ("SOAH") for a hearing on the merits. On July 13, 2022, Commission Counsel issued an Order Requesting Lists of Issues from the parties to assist the Commission in drafting a preliminary order. The Order Requesting Lists of Issues established a

deadline of July 27, 2022 for parties to respond with lists of issues. Therefore, this List of Issues is timely filed.

II. LIST OF ISSUES

The Order Requesting Lists of Issues seeks the identification of issues to be addressed in this docket. Aqua WSC respectfully requests that the following List of Issues be addressed in this docket:

1. Are the \$59,164.00 in costs described in Aqua WSC's preliminary cost summary to Jacob and Jennie Hilbig reasonably related to the cost of installing on-site and off-site facilities to provide service to the Appellant in accordance with the requirements of TWC § 13.043(g) and 16 TAC § 24.101(g)(2), and just and reasonable in accordance with the requirements of TWC § 13.043(j)?
2. Are the \$59,164.00 in costs described in Aqua WSC's preliminary cost summary to Jacob and Jennie Hilbig consistent with Aqua WSC's tariff in accordance with the requirements of TWC § 13.043(g) and 16 TAC § 24.101(g)(2)?

III. CONCLUSION AND PRAYER

Aqua WSC appreciates the opportunity to offer this List of Issues for Commission consideration. Aqua WSC respectfully requests that a preliminary order be issued that includes the above-stated issues.
