**COMMISSION STAFF'S CORRECTIONS TO THE PROPOSED ORDER**

On May 4, 2022, the Office of Policy and Docket Management (OPDM) filed a Proposed Order and Memorandum requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission), 2021 FII Walnut Springs, LLC (FII Walnut Springs), and Springs Hill Water Supply Corporation (Springs Hill WSC) to file any corrections or exceptions to the Proposed Order on or before May 18, 2022. Therefore, this pleading is timely filed.

**I. PROPOSED CORRECTIONS**

Staff has reviewed the Proposed Order and respectfully proposes the following corrections to the Proposed Order:

1. Revise Finding of Fact Nos. 15, 25, and 28 to correct the effective date of the deed, consistent with Finding of Fact No. 5.
  15. The petitioner acquired its 104.60-acre tract of land by special warranty deed, dated November ~~46~~15, 2021.
  25. The petitioner acquired its 0.19-acre tract of land by special warranty deed, dated November ~~46~~15, 2021.
  28. The petitioner acquired its 96.02-acre tract of land by special warranty deed, dated November ~~46~~15, 2021.
2. Revise Conclusion of Law No 6 to correct the citation.
  6. Under ~~46 TAC § 24.245(7)~~16 TAC § 24.245(h)(7), the Commission's decision is based on the information submitted by the landowner, the CCN holder, and Commission Staff.

## **II. CONCLUSION**

Staff respectfully requests that the Commission adopt the corrections proposed above.
