COMMISSION STAFF'S REQUEST FOR EXTENSION

On February 11, 2022, Undine Texas, LLC (Undine) filed an application for approval of a proposed pass-through rate change pursuant to 16 Texas Administrative Code (TAC) § 24.25(b)(2), and Ordering Paragraph No. 5, of the Notice of Approval filed in Docket No. 51828.¹ Undine proposes a pass-through rate change for three subdivisions: Spring Creek Valley Estates Subdivision in Harris County (Public Water System (PWS) No. 1010213); Hazy Hollow East Estates Subdivision in Montgomery County (PWS No. 1700013); and River Club Water Company in Montgomery County (PWS No. 1700185).

On July 28, 2022, the administrative law judge filed Order No. 7, establishing a deadline of August 3, 2022, for Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of the application and notice, and propose a procedural schedule, if appropriate.

I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff previously requested an extension stating that it required additional time to obtain information needed for its recommendation.² Staff originally believed it could obtain said information by this week, but it was mistaken. Staff thus respectfully requests additional time to obtain the missing information it needs to make its recommendation. Staff respectfully requests that Staff's deadline be extended to August 12, 2022, to allow Staff to complete its recommendation.

II. PROCEDURAL SCHEDULE

In accordance with Staff's extension request, Staff does not propose a procedural schedule for further processing of the docket at this time. Staff intends to propose a procedural schedule alongside a subsequent recommendation that the application be found administratively complete.

III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to August 12, 2022, to file its comments on the administrative completeness of the petition.
