## UNDINE TEXAS, LLC'S AGREED RESPONSE TO ORDER NO. 11 REQUIRING CLARIFICATION

COMES NOW, Undine Texas, LLC (Undine) and files this Agreed Response to Order No. 11 Requiring Clarification filed on September 22, 2022.<sup>1</sup>

In Kathryn Eiland's memorandum attached to Commission Staff's Information Filing, Ms. Eiland recommended that the administrative law judge (ALJ) open two compliance dockets to true-up the rates for the Spring Creek Valley Estates Subdivision, the Hazy Hollow East Estates Subdivision, and the River Club Water Company Subdivisions (collectively, the Nerro Systems).<sup>2</sup> On September 22, 2022, the ALJ issued Order No. 11 requiring Undine and Commission Staff to clarify whether the compliance dockets are still necessary and establishing a deadline of October 6, 2022, for a response.<sup>3</sup> Therefore, this Agreed Response is timely filed.

Undine and Commission Staff request that the ALJ open one compliance docket regarding the Nerro Systems to (1) true-up the difference between the Commission-approved rates and the requested rates charged from April 1, 2021, through April 30, 2022; and (2) true-up the difference between rates charged from May 1, 2022, through the date the ALJ approves Ms. Eiland's recommended pass-through rates in this proceeding.
