**COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION**

On February 11, 2022, Undine Texas, LLC (Undine) filed an application for approval of a proposed pass-through rate change pursuant to 16 Texas Administrative Code (TAC) § 24.25(b)(2), and Ordering Paragraph No. 5, of the Notice of Approval filed in Docket No. 51828.<sup>1</sup> Undine proposes a pass-through rate change for three subdivisions: Spring Creek Valley Estates Subdivision in Harris County (Public Water System (PWS) No. 1010213); Hazy Hollow East Estates Subdivision in Montgomery County (PWS No. 1700013); and River Club Water Company in Montgomery County (PWS No. 1700185).

On March 31, 2022, the administrative law judge filed Order No. 3, establishing a deadline of April 8, 2022, for Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of the application and notice, and propose a procedural schedule, if appropriate. Therefore, this pleading is timely filed.

**I. UNOPPOSED REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has identified issues with the tariff rates utilized in the application and needs additional time to coordinate with Undine. Accordingly, Staff respectfully requests that Staff's deadline be extended to May 2, 2022. Staff has conferred with Undine's counsel and is authorized to represent it is unopposed to the extension.

**II. PROCEDURAL SCHEDULE**

In accordance with Staff's extension request, Staff does not propose a procedural schedule for further processing of the docket at this time. Staff intends to propose a procedural schedule alongside a subsequent recommendation that the application be found administratively complete.
