## AGREED MOTION FOR AN AMENDED PROCEDURAL SCHEDULE

On February 11, 2022, Monarch Utilities I L.P. (Monarch) filed an application to amend its certificates of convenience and necessity numbers 12983 and 20899 in Harris, Liberty, and Montgomery counties. Monarch filed supplements to the application on March 8, 2022, and May 26, 2022.

On May 27, 2022, the administrative law judge filed Order No. 4, which established a procedural schedule requiring, among other things, the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable) to Monarch for review and consent by July 25, 2022. Therefore, this motion is timely filed.

# I. REQUEST FOR EXTENSION OF TIME AND MOTION FOR AMENDED PROCEDURAL SCHEDULE

Under Texas Administrative Code § 22.4(b), parties may request that the time allowed for filing any documents be extended for good cause. In response to discussion with Commission Staff regarding certain issues, Monarch intends to file an amendment to the Application that will affect the requested certificates and maps. In order to preserve Commission Staff's ability to adequately respond to the application amendment, Monarch, with the agreement of Staff, proposes the following procedural schedule:

Event	Number of Days from the Date the Application Amendment is Filed
Deadline for Commission Staff to file a recommendation on the administrative sufficiency of the application amendment	30
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to Monarch for review and consent	60
Deadline for Monarch to file signed consent forms with the Commission	67
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	74
If no hearing is requested, deadline for parties to file joint proposed findings of fact including proposed findings of fact, conclusions of law, and ordering paragraphs	81

### II. CONCLUSION

Monarch respectfully requests the entry of an order amending the procedural schedule as proposed. Commission Staff has reviewed this motion and agrees with the request.
