

CSWR-TEXAS UTILITY OPERATING COMPANY, LLC, CERTIFICATE OF CONVENIENCE AND NECESSITY (CCN) NO. 13290, NOTICE OF INTENT TO PURCHASE WATER FACILITIES AND TO TRANSFER WATER SERVICE AREA UNDER CCN NO. 13259 FROM SIMPLY AQUATICS, INC. IN MONTGOMERY, SABINE, AND SAN AUGUSTINE COUNTIES, TEXAS



has submitted an application with the Public Utility Commission of Texas (Commission) to purchase all of the water facilities and to transfer water certificated service area under CCN No. 13259, in Montgomery, Sabine, and San Augustine counties, TX from:

The requested area overlaps the district boundaries of:

- Angelina & Neches River Authority
- Sabine River Authority
- San Jacinto River Authority

If these districts do not request a public hearing, the Commission shall determine that the district is consenting to CSWR-Texas Utility Operating Company, LLC's request to provide retail water utility service in the requested area.

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivisions:

#### Requested Area 1 - El Pinon Estates Subdivision in San Augustine County

The requested area includes <u>88</u> customer connections, is located approximately <u>13</u> mile(s) <u>southeast</u> of Broaddus, Texas, and is generally bounded on the north by <u>County Road 478</u>; on the east by <u>approximately 110 feet east of County Road 485</u>; on the south by <u>approximately 120 feet south of County Road 488</u>; and on the west by <u>approximately 145 feet west of County Road 489</u>.

#### Requested Area 2 - La Playa Subdivision in San Augustine County

The requested area includes 28 customer connections, is located approximately 8 mile(s) <u>south</u> of downtown <u>Broadus</u>, Texas, and is generally bounded on the north by <u>County Road 4717 and County Road 4715 South</u>; on the east by <u>County Road 4715S</u>; on the south by Sam Rayburn Reservoir; and on the west by <u>Sam Rayburn Reservoir</u>.

#### Requested Area 3 - Vista Verde Subdivision in Montgomery County

The requested area includes 82 customer connections, is located approximately <u>4 mile(s) southeast</u> of downtown <u>Montgomery</u>, Texas, and is generally bounded on the north by <u>Breezy Dr.</u>; on the east by <u>South Pine Lake Road</u>; on the south by <u>Mail Route Road</u>; and on the west by <u>approximately 170 feet west of Shadow Lane</u>.

#### Requested Area 4 - Timberlane Subdivision in Sabine County

The requested area includes 47 customer connections, is located approximately <u>16 mile(s)</u> <u>east</u> of downtown <u>Hemphill</u>, Texas, and is generally bounded on the north by <u>Waters Edge N</u>; on the east by <u>Timberlane Dr.</u>; on the south by <u>Timberlane Loop</u>; and on the west by <u>Toledo Bend Reservoir</u>.

The total requested area includes <u>254</u> customer connections and approximately <u>523</u> acres of transferred area from Simply Aquatics, Inc (CCN No. 13259) to CSWR (CCN No. 13290).

The application proposes the subtraction of approximately <u>523</u> acres from CCN No. 13259 and the addition of approximately 523 acres to CCN No. 13290.

This transaction will not have an effect on the current customer's rates and services.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.






Requested Area 4 to Transfer - CCN No. 13259 (Timberlane) to CCN No. 13290 in Sabine County





Requested Area 1 to Transfer - CCN No. 13259 (El Pinon) to CCN No. 13290 in San Augustine County





Requested Area 2 to Transfer - CCN No. 13259 (La Playa) to CCN No. 13290 in San Augustine County


