COMMISSION STAFF’S PROPOSED PROCEDURAL SCHEDULE

On February 18, 2022, Mauka Water LP (Mauka Water) and James A. Dyche dba Crest Water Company (Crest Water) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Johnson County. Applicants seek approval to sell and transfer Mauka Water’s facilities and all of Mauka Water’s certificated area under CCN No. 12917 to Crest Water. The application reflects a requested area of 340 acres and 339 customers.

On August 2, 2022, the administrative law judge filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a procedural schedule by August 12, 2022. Therefore, this pleading is timely filed.

I. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Event	Date
Notice completed	July 18, 2022
Deadline for intervention	August 17, 2022 ¹
Deadline for Staff to request a hearing or file a recommendation on the approval of the sale and on the CCN amendment	September 16, 2022
Deadline for parties to file a response to Staff’s recommendation	September 30, 2022

¹ Pursuant to 16 Texas Administrative Code § 24.239(b), the intervention period shall not be less than 30 days unless good cause is shown. Notice was mailed on July 6, 2022, and published on July 11 and 18, 2022. Therefore, 30 days after July 18, 2022 is August 17, 2022.

² Pursuant to 16 TAC § 24.239(a) and (j), the deadline for Commission action is 120 days after the mailing or publication of notice, whichever occurs later. One hundred and twenty days after July 18, 2022 is November 15, 2022.
