**JOINT RESPONSE TO ORDER NO. 7**

On February 18, 2022, Applicants filed an application for approval of the sale, transfer, or merger (STM) of facilities and certificate rights in Johnson County. On October 20, 2022, Applicants and Commission Staff filed a Joint Motion to Admit Evidence and Proposed Notice of Approval.

In Order No. 7, the Commission Administrative Law Judge (ALJ) requested that the Parties clarify the description of some of the documents listed in their joint filing on or before October 28, 2022, specifically the reference to bate-stamped documents in Section I.B of the Motion to Admit Evidence. Therefore, this pleading is timely filed.

**I. CLARIFICATION TO MOTION TO ADMIT EVIDENCE**

Section I.B of the Motion to Admit Evidence referenced an entire range of bate-stamped documents 000001 through 000068, which were filed with the STM Application on February 18, 2022. The group of documents bate-stamped 000001 through 000068 included both confidential and non-confidential documents and inadvertently referenced documents other than the purchase agreement, customer deposits and financial information that are specifically identified in Section I.B. Instead, Section I.B should have referenced the specific sets of documents as follows: Applicants' confidential asset purchase agreement bate-stamped 000001 through 000041, the confidential list of customer deposits bate-stamped 000054 through 000060, and Crest's confidential financial information bate-stamped 000061 through 000068, all filed on February 18, 2022 as Interchange Item No. 2. The non-confidential document bate-stamped 000042 through 000053 is the 2017 James A. Dyche d/b/a Crest Water Company tariff which was filed as an attachment to the STM Application.

## II. CONCLUSION


