<u>The requested area overlaps the district boundaries of the Lower Colorado River Authority</u>. If this district does not request a public hearing, the Commission shall determine that the district is consenting to CSWR-Texas Utility Operating Company, LLC's request to provide retail water/sewer utility service in the requested area.

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following:

The requested area includes <u>67</u> customer connections, is located approximately <u>10.5</u> mile(s) <u>west</u> of downtown <u>Burnet</u>, Texas, and is generally bounded on the north by <u>Lake Buchanan</u>; on the east by <u>Ranch to</u> <u>Market Road 690</u>; on the south by <u>Lake Buchanan</u>; and on the west by <u>Lake Buchanan</u>.

The requested area includes approximately <u>58</u> acres of transferred area from Cassie Water (CCN No. 11663) to CSWR (CCN No. 13290).

The application proposes the subtraction of approximately <u>58</u> acres from CCN No. 11663 and the addition of approximately <u>58</u> acres to CCN No. 13290.

This transaction will not have an effect on the current customer's rates and services.



Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.




Requested Area to Transfer - CCN No. 11663 (Cassie Water) to CCN No. 13290 in Burnet County

Requested Area to Transfer - CCN No. 11663 (Cassie Water) to CCN No. 13290 in Burnet County




