COMMISSION STAFF'S MOTION TO AMEND PROCEDURAL SCHEDULE

On September 10, 2021, Blackland Water Supply Corporation (Blackland WSC) and the City of Rockwall (Rockwall) (collectively, the Petitioners) filed a petition to amend Blackland WSC's water certificate of convenience and necessity (CCN) No. 11305 under Texas Water Code (TWC) § 13.255(a) in Rockwall County, Texas in Docket No. 52551. In Order No. 2 in Docket No. 52551, the administrative law judge (ALJ) severed the CCN amendment proceeding, which became Docket No. 53262, the current proceeding. On March 25, 2022, the Petitioners filed the petition in Docket No. 53262 in accordance with Order No. 2 in Docket No. 52551.

On April 18, 2022, the ALJ filed Order No. 2, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable), to the Petitioners for review and consent by May 19, 2022. Therefore, this pleading is timely filed.

I. MOTION TO AMEND PROCEDURAL SCHEDULE

On May 13, 2022, the Petitioners filed an errata to the petition.¹ To allow Staff time to prepare final maps, certificates, and tariffs (if applicable) in accordance with the revisions made in the errata filing, Staff respectfully requests that its deadline to provide the Petitioners these documents be amended to June 20, 2022. Staff has conferred with counsel for the Petitioners who are unopposed to this request. Staff proposes the following amended procedural schedule:
