**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On February 24, 2022, Aqua Texas, Inc. (Aqua Texas) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 13201 in Parker County.

On May 25, 2022, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline of July 8, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the application. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. At this time, Staff requires more information and is propounding discovery on Aqua Texas. In order to allow time for Aqua Texas to respond to Staff’s discovery request and for Staff to review the responses before filing a final recommendation, Staff respectfully requests that the remaining deadlines be extended as detailed below.
