COMMISSION STAFF'S REQUEST FOR A RULING

On February 24, 2022, Aqua Texas, Inc. (Aqua Texas) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 13201 in Parker County.

On February 28, 2022, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of March 24, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and proposed notice. On March 24, 2022, Staff filed its recommendation that the application be found administratively complete, in which Staff also proposed a procedural schedule for Aqua Texas to file proof of notice by April 25, 2022 and for Staff to file a recommendation on the sufficiency of notice by May 9, 2022. To this date, an order ruling on Staff's recommendations and proposed procedural schedule has not been filed. As such, Staff respectfully files this request for a ruling on Staff's recommendation that the application be found administratively complete and that Aqua Texas proceed with providing notice.

I. AMENDED PROPOSED PROCEDURAL SCHEDULE

In light of the pending deadlines previously proposed and referenced above, Staff respectfully proposes the following procedural schedule as amended below:

Event	Date
Deadline for Aqua Texas to file with the Commission signed affidavits that the notice was given along with a copy of the notice and map sent to the affected parties and published in a newspaper of general circulation	May 9, 2022
Deadline for Staff to file a recommendation on sufficiency of notice	May 23, 2022
Deadline to intervene	30 days after notice is issued

II. CONCLUSION

For the reasons detailed above, Staff respectfully recommends that the application is administratively complete, that Aqua Texas proceed with providing notice, and that the amended proposed procedural schedule be adopted. Staff respectfully requests the entry of an order consistent with these recommendations.
