- 2. On February 24, 2022, AEP Texas Inc. ("AEP") filed an application for approval of a new Wholesale Distribution Service Distributed Generation ("WDS DG") Energy Storage Tariff to establish rates and other terms and conditions for distributed generation energy storage facilities that take wholesale service at distribution voltage from AEP.
- 3. SMT McAllen is developing a battery energy storage project within the AEP service territory that will be interconnected at distribution voltage. SMT McAllen has applied for interconnection with AEP Texas and is currently in the interconnection study process. SMT McAllen is therefore directly affected by the application filed, and the decisions made, in this docket.
- 4. For the above stated reasons, SMT McAllen respectfully requests that the Commission grant this Motion to Intervene and admit SMT McAllen as an intervenor in this proceeding for all purposes, and for such other relief to which it may be justly entitled.
