**COMMISSION STAFF’S UNOPPOSED MOTION TO AMEND PROCEDURAL  
SCHEDULE**

On March 1, 2022, Crystal Bluff Goat Ranches, LLC (Crystal Bluff) filed an appeal of the cost of obtaining service from Possum Kingdom Water Supply Corporation (Possum Kingdom WSC) under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On April 20, 2022, the administrative law judge filed Order No. 3, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the petition or to request a final hearing by June 16, 2022. Therefore, this pleading is timely filed.

**I. MOTION TO AMEND PROCEDURAL SCHEDULE**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On June 14, 2022, Crystal Bluff requested an extension to file a response to Possum Kingdom WSC’s Plea to the Jurisdiction and Motion to Dismiss to Monday, June 20, 2022. To allow time for a ruling on Crystal Bluff’s motion, as well as time for the parties to seek informal resolution before possible referral to SOAH, Staff respectfully requests that the procedural schedule be amended. Staff has conferred with counsel for Crystal Bluff and Possum Kingdom and is authorized to state that they are unopposed to this request. Staff respectfully requests the following amended procedural schedule:

Deadline for Commission Staff to file a final recommendation on the petition or to request a hearing	July 18, 2022
Deadline for parties to respond to Commission Staff's recommendation or to request a hearing; if no hearing is requested, deadline to file a proposed order	August 18, 2022
