COMES NOW, Crystal Bluff Goat Ranches, LLC ("CBGR"), and files this Request for Extension to File Prefiled Testimony and Exhibits, and would show the following in support:

- 1. CBGR recently retained co-counsel, Art Rodriguez, in this matter on November 28, 2022, and requests that co-counsel be allowed additional time to review the file, the proposed prefiled testimony, and proposed exhibits prior to filing.
- 2. CBGR requests that the deadline for its prefiled testimony and exhibits be extended two weeks from December 1, to December 15, 2022.
