POSSUM KINGDOM'S MOTION TO ENTER REVISED PROCEDURAL SCHEDULE

COMES NOW, Possum Kingdom Water Supply Corporation (Possum Kingdom), and files this Motion to Enter Revised Procedural Schedule for the above- referenced case.

MOTION

In SOAH Order No. 3, the parties were ordered to confer and submit an agreed revised procedural schedule no later than December 30, 2022.¹ Possum Kingdom received no correspondence from Crystal Bluff Goat Ranches, LLC (CBGR) regarding a revised procedural schedule after SOAH Order No. 3 was issued. On December 28, 2022 Possum Kingdom reached out to CBGR's counsel regarding the schedule issue inquiring whether CBGR would be preparing a schedule with appropriate extensions. CBGR is the appellant/applicant and the party whose requested direct testimony deadline extension prompted the need for a revised schedule.

On the evening of December 30, 2022, Possum Kingdom received a proposed schedule from CBGR's counsel. Possum Kingdom shared comments on that proposed schedule with CBGR's counsel and Commission Staff on January 2-3, 2023. It was Possum Kingdom's understanding that CBGR was going to file a revised procedural schedule agreed to by the parties, but to date, that has not occurred. The old schedule includes a deadline for objections to CBGR's direct testimony that should be moved back under the revised schedule.

¹ SOAH Order No. 3 Granting Request for Extension; Requiring Conference (Dec. 7, 2022). The Public Utility Commission of Texas was closed on Dec. 30, 2022 and Jan. 2, 2023 making the deadline for filing a revised schedule Jan. 3, 2023.

Consequently, Possum Kingdom respectfully requests that the SOAH Administrative Law Judge (ALJ) enter an order adopting the following revised procedural schedule.
