**COUNTY LINE SPECIAL UTILITY DISTRICT AND MAXWELL SPECIAL
UTILITY DISTRICT'S SUPPLEMENTAL JOINT CLARIFICATION**

COMES NOW, County Line Special Utility District (CLSUD) and Maxwell Special Utility District (MSUD) (collectively, Petitioners) and hereby file this Supplemental Joint Clarification. In support thereof, Petitioners would respectfully show as follows:

I. BACKGROUND

On March 7, 2022, CLSUD and MSUD filed a petition for approval of a service area contract (Petition) at the Public Utility Commission of Texas (Commission). The Petition included an interlocal agreement that contemplated the exchange of 152.3 acres of land from CLSUD's Certificate of Convenience and Necessity (CCN) No. 10292 service area to MSUD's CCN No. 10293 service area, and 4.7 acres of land from MSUD's CCN No. 10293 service area to CLSUD's CCN No. 10292 service area (Agreement). However, the map included in the Petition contemplated a larger water CCN service area to be swapped than by the Agreement. Consequently, CLSUD and MSUD then executed an addendum to the Agreement (Addendum), redefining the water CCN service area to be swapped as transferring 384.7 acres of land from CLSUD's water CCN service area to MSUD's water CCN service area, and 60.4 acres of land from MSUD's water CCN service area to CLSUD's water CCN service area, as depicted in the Petition's maps.

The parties then filed an Amended Petition at the Commission on June 20, 2022, seeking Commission approval of the Agreement, as redefined by the Addendum. The Petitioners also filed a Joint Clarification on July 1, 2022, explaining a minor discrepancy with the shapefiles, and clarifying the acreage to be transferred. On July 20, 2022, Commission Staff recommended that the Petition, as amended, be deemed administratively complete. Then on July 21, 2022, the Administrative Law Judge issued Order No. 4 deeming the application administratively complete.

II. SUPPLEMENTAL CLARIFICATION

The Petitioners' prior Joint Clarification accurately explained the mapping discrepancy but there was a typographical error in the concluding sentence in labeling which entity will receive which acreage. In order to have an accurate record in this Docket for technical review, CLSUD and MSUD now clarify that the requested area includes 0 customer connections and approximately (1) 60.7 acres of transferred area from MSUD (CCN No. 10293) to CLSUD (CCN No. 10292); and (2) 384.7 acres of transferred area from CLSUD (CCN No. 10292) to MSUD (CCN No. 10293), as described in the Addendum and shown in the maps.


III. CONCLUSION AND PRAYER

For these reasons, CLSUD and MSUD respectfully request that the Administrative Law Judge accept and apply this supplemental clarification to the Amended Petition and grant all other and further relief to which they may be entitled.


